In the 22–23 fiscal year, Voices for Children supported 521 local children in foster care in Riverside County through our CASA program.

This achievement is particularly significant as it represents the highest number of youth served in a single year since the Riverside County program’s inception in 2015. The Riverside County CASA program started with four staff members serving 70 children. Seven years later, the Riverside County CASA program has 13 dedicated staff members serving 521 children with the support of countless community partners who believe in our mission. Most importantly, Voices for Children has become a trusted organization with a reputation for making a positive difference in the lives of children in foster care.

The trust that has been built over the years in the community led to our groundbreaking partnership with the Pechanga Band of Indians. The Pechanga Band of Indians is a sovereign government with its own tribal court proceedings, and Voices for Children is honored to serve as the designated CASA program for any child under the jurisdiction of Pechanga’s Tribal Court.

This past year, the Riverside County CASA program also focused on creating opportunities in the Desert and Metro regions of Riverside County, addressing the different demographic profiles within the area, growing their philanthropic efforts, and surpassing their funding goals. To support the growing number of children needing a CASA, the Riverside County CASA program continues to inspire

new volunteers through its first CASA Outreach Team, which includes 25 CASAs working directly with Voices for Children to share their experiences in the community and help recruit future CASAs.

In this report, you will read about inspiring advocacy by our outstanding CASAs who make a difference for children and families of all cultures, abilities, identities, and backgrounds. We will also commend the talented, caring people and partners supporting our work. From our donors and sponsors to community-based organizations with whom we collaborate, we are changing the lives of children in foster care together.

A CONSISTENT PRESENCE, A CARING HEART



“Sally*” and her baby sister entered foster care when she was four years old due to neglect and exposure to drug use by her parents. CASA Brenda was assigned to Sally when she was five, and they have since developed an inseparable bond.

The Court ultimately terminated Sally’s parents’ parental rights and placed Sally and her sister up for adoption. Fortunately, Sally and her sister were not separated, as some siblings are, when placed in foster care. Her grandmother became their relative caregiver and decided to adopt Sally and her sister.

CASA Brenda has gone above and beyond to consistently support and advocate for Sally. When Sally was having a hard time at school, she found comfort in knowing she could count on CASA Brenda to listen and just let her be a kid. Her grandmother informed the Court that she is thankful to have CASA Brenda in Sally’s life. She also shared Sally’s excitement whenever she knows CASA Brenda is coming for an outing: Sally eagerly waits by the door and asks her grandmother, “Is Brenda almost here?”

Sally loves learning and experiencing new things. CASA Brenda takes Sally to museums, science centers, libraries, and historical monuments, and they have a tradition of ending the day eating mozzarella sticks and drinking slushies.

Recently, they visited a park during an outing and made friendship bracelets together. Since then, Sally has not taken off the bracelet CASA Brenda made for her.

Sally has told her grandmother she considers CASA Brenda her best friend and that she wishes everyone had a CASA.

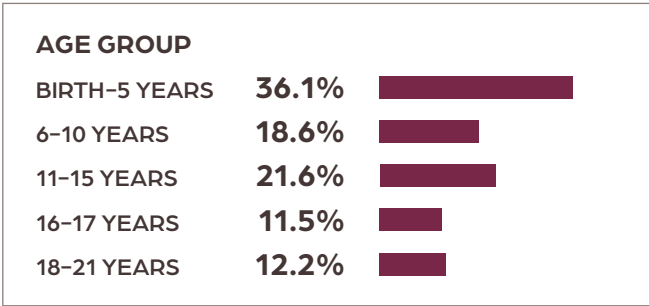
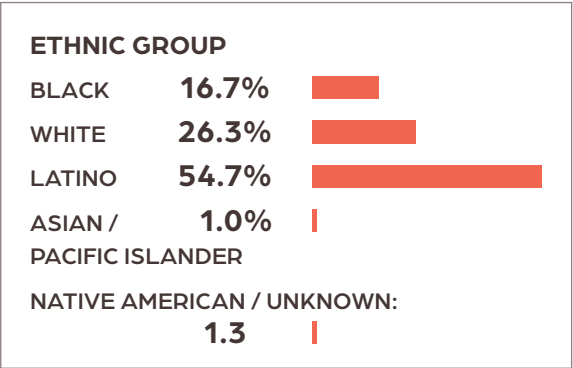
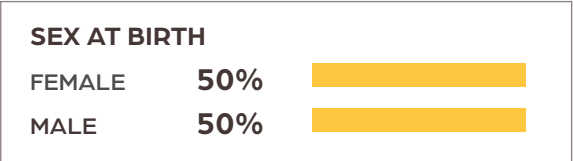
Recently, the girls were officially adopted, and their grandmother is grateful to start a new chapter together with her granddaughters.

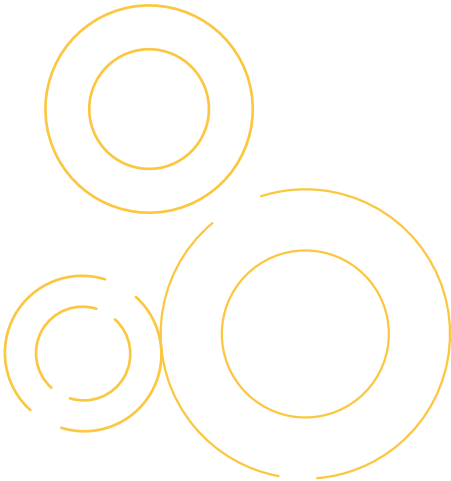
