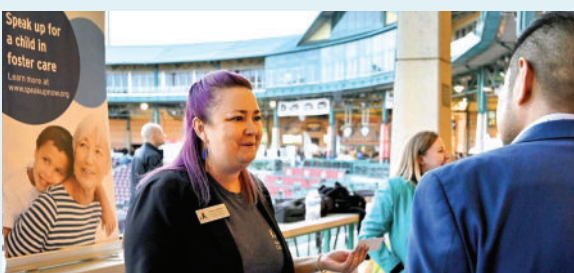

# Meeting the Moment: *CASAs support children's mental health throughout their foster care journeys*

According to the National Foster Youth Institute, on average, **4 out of every 5 children** who enter foster care do so with severe mental health needs.



Each child we serve has suffered Adverse Childhood Experiences (ACEs): traumatic events that occur in childhood that can include neglect, abuse, or growing up in a family with mental health or substance use issues. The presence of ACEs can have long-term consequences in a youth's life through adulthood, being linked to chronic health problems, high-risk behaviors, mental illness, and more. However, our Court Appointed Special Advocate (CASA) model is designed to support youth or children who have experienced such trauma. The presence of a supportive adult relationship can serve as an influential factor against the adverse effects of childhood trauma.

### How CASA volunteers build resilience in trauma-impacted youth

CASAs pay attention. They stand by children throughout their time in foster care, showing them they can rely on adults. CASAs learn about children's unique mental health needs by spending time with them and speaking with members of the children's support network. They monitor their access to mental health services and progress on therapeutic goals. When children encounter barriers to receiving critical mental health services, CASAs collaborate with the children's social worker, attorney, and judge to find solutions.

The American Academy of Pediatrics Healthy Foster Care America Initiative identifies mental and behavioral health as the "greatest unmet health need for children and teens in foster care." Through their advocacy, CASAs help break down barriers to help youth in foster care get the mental health support that they need.

### Being there through all the ups and downs

Since 2021, CASA Christina has been a consistent advocate for Jonathan\*, an adolescent boy who struggles with mental health challenges and developmental delays. She has been a constant in his life through multiple changes in placements, schools, and services. Through her advocacy, Jonathan is now in a placement that allows him to receive therapeutic services. CASA Christina also serves as his educational rights holder. As Jonathan approaches high school graduation, she helps make the best decisions regarding his academic success.

When asked how she supports Jonathan's mental health as his CASA, she shared, **"I have established receptive communication with the therapist, the school, and daily mental health staff. The cooperative sharing of information regarding behavior, medication, and mood observations has helped determine a more fluid treatment plan for him."**

When Jonathan is having a tough time, CASA Christina picks up his favorite meal or takes him for a car ride to sing songs playing on the radio, providing a welcome distraction. These small gestures and the consistency of CASA Christina's presence allow Jonathan to experience a trusting relationship and relieve his stress of "not knowing what to expect" from an adult. With this established stability, Jonathan can feel hope and explore possibilities about his future beyond simply surviving.



### Listening, learning, and supporting

For over a year and a half, CASA Tracey has diligently served as an advocate for her assigned youth, 18-year-old Mariana. She is a vibrant teen with a great sense of humor, enjoys interacting with others, and has a positive outlook on life despite the adversity she has endured. However, before she had the consistency and stability of a CASA in her life, Mariana struggled to regulate her emotions and develop coping mechanisms to make healthy choices. Needing mental health support, Mariana has been receiving treatment outside of San Diego County. Nonetheless, CASA Tracey frequently visits, schedules video chats, and has consistent calls with her, building a very close relationship. Working with Mariana's case manager, social worker, and teachers, CASA Tracey did everything possible for Mariana to complete all the requisites to

finish high school successfully. After many study sessions, Mariana received her high school diploma in 2023, feeling proud of herself for everything she had accomplished. With her CASA's presence and support, Mariana is prospering through her recovery, working part-time, and attending a local college.

*"Trust and stability are so important. Consistency of a routine and listening makes the youth feel heard, seen, happy, accepted, and cared for. All these things are often missing from their childhood. ### Exploring every possible resource

In 2021, CASA Ashley met 14-year-old Sophia\*, a young teen with multiple developmental diagnoses and mental health illnesses who had been abandoned numerous times. Her intricate medical history made it challenging to identify a suitable placement. CASA Ashley worked tirelessly to find a supportive placement for Sophia. After three years of exhaustive search efforts, Sophia is now in a small-scale, short-term residential therapeutic program. She is receiving specialized round-the-clock care and therapeutic behavioral services. Sophia is also supported by a dedicated team of mental health specialists, offering a ray of hope in her challenging mental health journey.

When she first met Sophia, CASA Ashley felt she needed to plan engaging activities for their outings. Over time, she realized Sophia enjoyed activities like walking or hiking. **"My youth was enduring so much mental and emotional stress in her day-to-day that quieter and simple visits were providing her the emotional break that she needed,"** shared CASA Ashley. CASA Ashley's consistent advocacy for Sophia has enabled her to trust an adult for the first time in a long time, setting a new course for building and caring for future relationships with others. Sophia's path to recovery is still unfolding slowly, but CASA Ashley's commitment remains steadfast in navigating her journey, finding practical solutions, and providing a promising environment for her.

### How Voices for Children trains CASAs to advocate for children's mental health

Our training through Advocate University introduces all CASA volunteers to different types of trauma youth may have endured, focusing on ways that youth respond to trauma, behaviors of concern, and how trauma can have a significant effect on their

mental health. Due to CASAs' unique one-on-one advocacy, they may be the first or only person to observe a warning sign that indicates the child is struggling with their mental health.

*"One of the first things that we try to teach is that trauma isn't 'cured' by removing a youth from an abusive or neglectful environment."*

VFC offers a multi-disciplinary training curriculum incorporating childhood mental health research and trauma-informed child advocacy, including:

- Guidance on how to work with various mental health professionals
- Understanding and supporting children affected by trauma, particularly concerning the risk factors for emotional distress in teens, transitional age youth, and LGBTQ+ youth
- Strategies for developing cultural competency skills, identifying bias, and creating a sense of belonging

All of children's experiences, neglected or not, will impact their mental health in one way or another. A CASA is equipped with the empathy, patience, and skills to bring issues to light and offer trusted, consistent support to their youth. CASAs cultivate dependability, confidence, and self-awareness. Every child in foster care deserves a chance at a happy and healthy future, and our CASAs do just that as they help improve the lives of the children they advocate for.

The role of a CASA isn't just meaningful; it's transformative.

## CASA Volunteer's Tireless Commitment Leads To Adoption

In 2016, CASA Kelly was assigned to his second case, Caleb\*, a one-year-old infant who is developmentally delayed and was abandoned by his mother. CASA Kelly answered the call to be Caleb's advocate, and the two formed a special connection in the following years, including memorable moments and milestone achievements such as Caleb's first words, first steps, first days at school, summer camps, and more.

CASA Kelly worked closely with Caleb's social worker, caregiver, and medical specialists. Together, they helped monitor his complex health conditions and ongoing medical needs. They also collaborated and advocated for Caleb's education, getting him the best schooling and support, including full-time aides, adapted physical education, and music therapy.

Caleb's caregiver made it known she wished to adopt him and provide him with his forever home. The caregiver and CASA Kelly navigated the adoption process together. Through countless hours of advocacy and a deep commitment to his well-being, CASA Kelly supported Caleb's caregiver and helped pave the way for a successful adoption. The adoption was finalized in October 2023, and Caleb is now in a permanent loving home. CASA Kelly says it brings him great joy to know how far Caleb has come and with the love and support that he has today, he's looking forward to seeing how much more Caleb can thrive and reach his fullest potential.

## Meet Dr. Cynthia, a CASA Volunteer Who Does It All

Dr. Cynthia began her journey as a Court Appointed Special Advocate (CASA) while completing her doctorate in educational leadership in San Diego. She learned about Voices for Children (VFC) from a colleague, attended an information session, and was assigned to her first case in 2008.

For 11 years, she served as a CASA for three brothers who were placed apart and had different permanency plans. As their CASA, she happily chaperoned a 'prom night,' attended high school graduations, and more. Being there for the boys' birthdays and other milestones over the years was rewarding to Cynthia, especially knowing they did not have anyone else there to celebrate them. Throughout her time on their case, the boys had multiple attorneys, several social workers, and countless placements. She learned firsthand the importance of being the one consistent person in the life of a youth in foster care. When reflecting on her case, Cynthia said, **"The boys learned to trust that I would show up when expected and would advocate for their best interests."** This consistency allowed her to build a strong relationship with the boys that continues to this day.

When the case closed in 2019, Cynthia stayed involved with VFC as a member of the CASA Outreach Team, a group of CASAs who represent VFC throughout San Diego County. She has given presentations, shared her experience with potential CASAs during information sessions, posted fliers, and worked booths at community events. When Cynthia retired and relocated to Menifee, her support

for VFC did not stop there. She then got involved with VFC's Riverside County program and worked with Riverside County's CASA Recruitment and Outreach Manager, Kathi Shaner, to create a CASA Outreach Team for Riverside County, which now consists of 30 members.

Cynthia also decided she was ready for a new case. This time, she was assigned to a case in Riverside County. With her experience and adaptiveness, she is now the CASA to siblings through our Pechanga Tribal Court CASA program. As only the third CASA to be assigned through this program, Cynthia enjoys getting to know the family and recently completed her first court report.

In addition to the thousands of hours Cynthia has volunteered to VFC, she has made generous financial contributions to the San Diego and Riverside County programs. Although all CASAs are extraordinary, Cynthia is a clear example of someone who has gone above and beyond her commitment as a CASA.

### Las Patronas: More Than Three Decades of Supporting VFC

Few organizations have supported Voices for Children (VFC) for as long as Las Patronas, a philanthropic organization that has been helping San Diego charities since 1946. Since its inception, Las Patronas has donated nearly \$27 million to more than 1,000 organizations. VFC has been benefiting from the generosity of Las Patronas since 1992.

We were delighted to have been selected as one of two fall Legacy Society Beneficiaries. This recent grant allowed us to purchase a mission-critical videoconferencing set-up. This videoconferencing technology will enable our staff to have emergency meetings about the children we serve and enhance our Court Appointed Special Advocate (CASA) information sessions, training classes, and more.

Las Patronas has awarded VFC with 11 capital grants since 1992. The previous grant, in 2020, helped establish a resource studio for transitional age youth at the main Juvenile Courthouse. We greatly appreciate the decades of support Las Patronas has provided; it has tremendously impacted our ability to help San Diego County children in foster care.

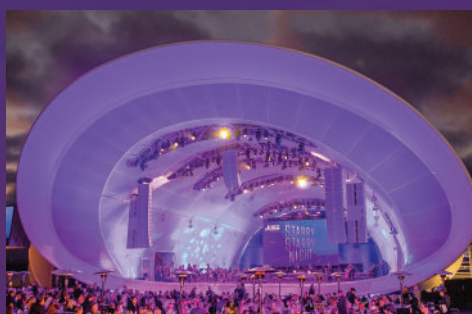
