A Decade of Dedication

Ten years ago, Riverside County's most vulnerable children lost a vital support when the previous local CASA program closed. Voices for Children (VFC) stepped in, determined to fill that gap and ensure every child in foster care had a voice in court and in the community. With just two staff members, one in the desert and one in southwest Riverside, and no formal office or infrastructure, our journey began with grit, heart, and determination.

From humble beginnings, the VFC Riverside County CASA program has grown into a thriving program with 18 dedicated staff members, three fully operational offices, and an expansive volunteer network. This transformation has been driven by responsive leadership, authentic community partnerships, and a steadfast belief that every child deserves consistent, trusted advocacy, especially during the brief and formative years of childhood. These early years are finite and irreplaceable, and for children in foster care, the window to experience stability, connection, and emotional growth can close all too quickly.

Recognizing this urgency, VFC has reached key philanthropic milestones, which enabled the opening of a third office, the expansion of staff, and the creation of a pivotal new role: the Distance Advocacy Specialist (DAS). This role has been transformative, ensuring that even children placed far from home, including as far away as Northern California, receive consistent, compassionate support. In FY24–25, VFC proudly served 730 children across Riverside County. Of those, 35 received dedicated support from our Distance Advocacy Specialist, ensuring that, regardless of where a child is placed, they remain supported and prioritized.

Volunteer recruitment has surged, fueled by word-of-mouth referrals and strong community awareness, a strategy now central to our outreach efforts. Many CASAs joined after hearing about the work through friends, colleagues, or former

advocates. These personal connections have helped diversify our volunteer pool, with notable increases in male and African American CASAs, as well as advocates willing to take on sibling groups, preserving vital family bonds.

Community support remains a cornerstone of our progress. Partnerships with local businesses, County Supervisors, Riverside County Department of Public Social Services (DPSS), and the courts have provided essential resources that have been instrumental to our growth. We are especially proud of our growing relationship with the Pechanga Band of Indians. This past fall, we were invited to present at the 32nd Annual California Indian Child Welfare Act (ICWA) Conference, highlighting our collaborative efforts in supporting Native American families in care.

As we celebrate this decade of impact, central to this success is our exceptional staff, a team distinguished by their compassion, dedication, and expertise. Our committed team works tirelessly each day to advocate for the rights of children in foster care. Our mission is clear: to meet the rising needs of children entering care by strengthening our capacity and broadening our reach. With continued community support, we will ensure every child in foster care has a dedicated advocate by their side.

A decade ago, we stepped into a moment of urgent need. Today, we stand firm, amplifying the voices of hundreds of children and creating brighter futures.

PROGRAM IMPACT: ADVOCATING FOR FAMILY, ENSURING PERMANENCY



When “Ana”, “Alice”, and “Athena” entered foster care after a profoundly traumatic event, their lives could have been fractured not just by circumstance, but by separation. Thanks to the steadfast advocacy of Court Appointed Special Advocate (CASA) Barbara, the girls’ story is not one of separation, but of unity — one marked by family resilience, compassion, and the enduring impact of advocacy.

Appointed to the case in 2024, CASA Barbara stepped into a complex family dynamic already in motion. The three sisters, bright, spirited, and deeply bonded, had been placed with their maternal aunt and uncle following their removal from their biological mother’s care in 2022. While the aunt and uncle provided a safe and loving home, they initially declined to pursue legal guardianship, wanting to maintain their role as extended family rather than permanent caregivers.

Throughout the case, CASA Barbara maintained consistent visits with the girls, listening, observing, and nurturing their sense of stability. She met them where they were: from joyful afternoons spent choosing toys on a holiday gift card budget, to reading books to shelter animals, to laughing and playing at the park until

the sun began to set. These moments became the foundation for trust, healing, and growth. CASA Barbara paid attention not just to their needs, but also to their joy, development, and individuality. Ana, a natural leader, thrived in the student council. Alice, patient and steady, found pride in her accomplishments. Athena, playful and curious, is thoughtful in her schoolwork and demonstrates care when printing her letters, as well as keeping her backpack perfectly organized for each school day.

CASA Barbara didn’t just advocate for the girls; she supported the entire family system. When discussions around out-of-county adoption emerged in early 2025, she became a critical link between the aunt and uncle, social services, and the court. She held space for the aunt and uncle to voice their fears of losing connection with the girls. She helped them navigate the complexities of legal guardianship, providing information about available financial support and what a long-term commitment could entail for their family.

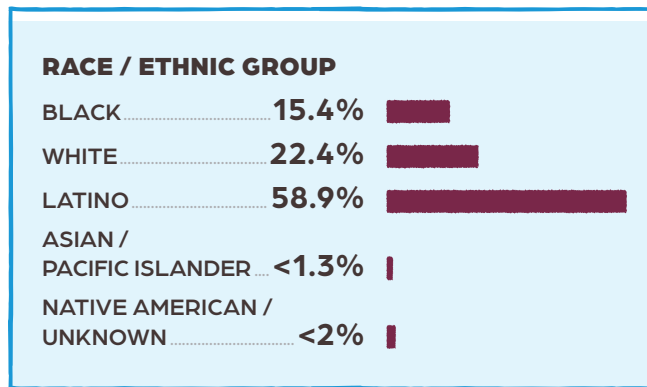
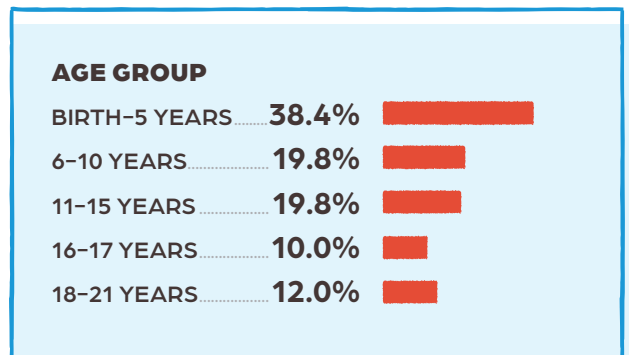
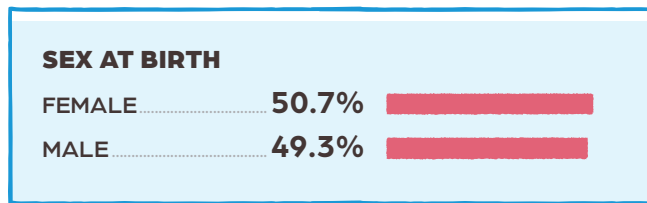
In May 2025, the aunt and uncle reached out to CASA Barbara with a life-changing decision: they would pursue legal guardianship. They shared that their love for the girls had only deepened, and with a better understanding of the support systems in place, they were ready to provide their nieces with a forever home. The court granted legal guardianship in the summer of 2025, and the dependency case was formally closed.

This heartwarming outcome, three sisters remaining together in a home they know, with a family that cherishes them, is a direct reflection of CASA Barbara’s tireless, child-centered advocacy. She ensured Ana, Alice, and Athena’s voices were heard. She listened and empowered their caregivers to step into a permanent role. Through her consistency, compassion, and commitment, what began as a temporary placement became a forever family.

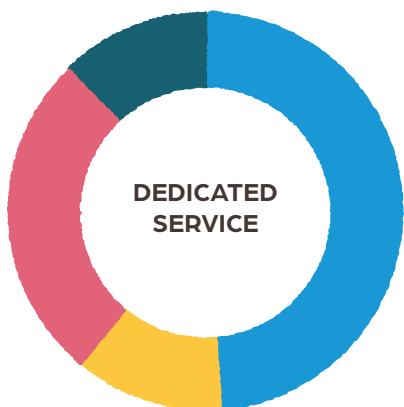



"Daniel" entered foster care at age 10 but didn't meet his CASA volunteer, Tiffany, until he was 14. Since 2020, she has been a steady and supportive presence in his life. Thanks to her advocacy, Daniel received vital services like speech therapy, medical care, and educational support, which helped him overcome challenges and gain confidence. When he shared how much he missed his sister, CASA Tiffany helped reunite them, a moment that meant everything to him. She has celebrated his milestones, stood by him through setbacks, and was even the one he trusted to take him to his first job interview. Now 18, Daniel is on track to graduate from high school and plans to pursue a career through trade school.
